- 2. With effect from 29 March 2011 after completion of the Open Offer:
 - the exercise price of the Options has been adjusted from HK\$1.070 to HK\$1.062;
 - the Options carrying subscription rights to subscribe for a total of 37,370,000 Shares and exercisable up to the expiry date on 31 December 2012 has been adjusted to a total of 37,653,106 Shares, in which Options to subscribe for a total of 2,498,832 Shares were lapsed during the month; and
 - the Options carrying subscription rights to subscribe for a total of 39,450,000 Shares and exercisable up to the expiry date on 31 December 2013 has been adjusted to a total of 39,748,863 Shares, in which Options to subscribe for a total of 2,811,091 Shares were lapsed during the month.
