1. The Convertible Notes due 12 January 2014 were issued on 12 January 2009. With effect from 12 March 2010, the Conversion Price has been adjusted from HK\$0.74 per share to HK\$0.73 per share.
2. With effect from 29 March 2011 after completion of the Open Offer, the exercise price of the Options has been adjusted from HK\$1.070 to HK\$1.062.
3. A number of 29,940,204 Options with an expiry date on 31 December 2012 were lapsed on 31 December 2012. The remaining 30,353,129 Options were having an expiry date on 31 December 2013.
4. The outstanding options refer to a total number of 105,900,000 Options at exercise price of HK\$0.49 per share which were granted and vested in June 2012 to October 2012. All the Options are exercisable from 6 October 2012 to 30 June 2016.
