On 13 October 2016 (after trading hours), (1) the Company and Wuling (Hong Kong) Holdings Limited (“Wuling HK”) entered into the Subscription Agreement pursuant to which the Company conditionally agreed to issue, and Wuling HK conditionally agreed to subscribe for, the Convertible Notes A in the aggregate principal amount of HK\$400,000,000; (2) the Company entered into the Placing Agreement with the Arranger (namely, China Industrial Securities International Capital Limited) as the exclusive arranger and one of the joint placing agents, and Essence International Securities (Hong Kong) Limited, GF Securities (Hong Kong) Brokerage Limited and CCB International Capital Limited as the joint placing agents, for the purpose of procuring subscribers, on a best efforts basis, to subscribe for, and the Company has conditionally agreed to issue, the Convertible Notes B in the aggregate principal amount of up to HK\$300,000,000. Based on the initial Conversion Price of HK\$0.70 per Share (subject to adjustment), a maximum of 571,428,571 Conversion Shares A and 428,571,429 Convertible Shares B will be allotted and issued upon exercise of the Conversion Rights in full, respectively.
