## ANNOUNCEMENT

The Board announces the details of trading balances due from an entity as at 17 August 2004 pursuant to Rule 13.14 of the Listing Rules.

### DISCLOSURE PURSUANT TO RULE 13.14 OF THE LISTING RULES

Reference is made to the announcement dated 24 September 2004 (the "Announcement") of ITC Corporation Limited (the "Company") for the disclosure pursuant to Rules 13.13, 13.14 and 13.15 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules") for details of advances to, and trading balances due from, certain entities.

The board of directors of the Company (the "Board") wishes to disclose pursuant to Rule 13.14 of the Listing Rules details of increase in trading balance due from an entity (as defined in Rule 13.11(2)(c) of the Listing Rules) to Paul Y. - ITC Construction Holdings Limited, which was a subsidiary of the Company until 20 October 2004 and is an 49.6% associated company of the Company as at the date of this announcement, and its subsidiaries (the "Paul Y. - ITC Group"), which increased by more than 3% of one or more of the relevant percentage ratios as set out in Rule 14.07 of the Listing Rules over the amount as disclosed in the Announcement.

As at 17 August 2004, the trading balance including retention monies ("Trade Receivable") due from Highways Department to Paul Y. - ITC Group increased by approximately HK\$8,404,000 as compared with the balance of approximately HK\$22,251,000 as at 31 May 2004 as disclosed in the Announcement to an aggregate balance of approximately HK\$30,655,000. The increase represented 4.6% of the Company's average market capitalisation for the five business days immediately preceding 17 August 2004.

The Trade Receivable is unsecured, interest free and with payment terms within 1.5 months from the date of certification and arose from construction services rendered by the Paul Y. - ITC Group.
