Dear New Registered Shareholder,

instead of receiving printed copies by mail; or

Option 2: to receive by mail the printed English version of all future Corporate Communications only; or Option 3: to receive by mail the printed Chinese version of all future Corporate Communications only; or

Option 4: to receive by mail both the printed English and Chinese versions of all future Corporate Communications.

If the Company does not receive the Reply Form or a response from you by 15 July 2017, you will be deemed to have consented to receive the Website Version, and a notification of the posting of Corporate Communications on the website of the Company will be sent to you in the future.
