

NOTICE OF ANNUAL GENERAL MEETING TOGETHER WITH PROPOSED GENERAL MANDATES TO REPURCHASE SHARES AND ISSUE SHARES, PROPOSED AMENDMENT OF COMPANY BYE-LAWS AND PROPOSED REFRESHMENT OF THE SHARE OPTION SCHEME MANDATE LIMIT

1. INTRODUCTION

This circular contains an explanatory statement to be sent to shareholders of the Company in compliance with the Listing Rules to give all the information reasonably necessary to enable them to make an informed decision on whether to vote for or against the resolutions to approve the Repurchase Mandate, Share Issue Mandate, the amendment of the Company's Bye-Laws and the refreshment of Share Option Scheme mandate limit.

2. GENERAL MANDATES TO REPURCHASE AND ISSUE SHARES

At the Annual General Meeting of the Company to be held on 29th December 2006, an Ordinary Resolution will be proposed to renew a general mandate previously granted to the Directors, on the terms

set out in the notice of the Annual General Meeting, allowing them to exercise all powers of the Company to repurchase its fully-paid Shares. Under such a mandate, the number of Shares that the Company may repurchase shall not exceed 10 per cent of the issued share capital of the Company at the date of passing the Ordinary Resolution. The Company's authority shall be restricted to repurchase made on the Stock Exchange.

The mandate allows the Company to make repurchases only during the period ending on the earliest of the date of the next annual general meeting, the date by which the next annual general meeting of the Company is required by any applicable law or the Company's Bye-Laws to be held or the date upon which such mandate is revoked or varied by an ordinary resolution of shareholders of the Company in general meeting.

It will also be proposed to grant a general mandate to the Directors, in the terms set out in the notice of the Annual General Meeting, allowing them to exercise all powers of the Company to allot, issue and deal with Shares not exceeding 20 per cent of the issued share capital of the Company at the date of passing the related Ordinary Resolution, to provide flexibility to the Directors if desirable.

An Ordinary Resolution will also be proposed at the Annual General Meeting to authorise the extension of the Share Issue Mandate by adding to the mandate the number of Shares to be repurchased by the Company under the Repurchase Mandate in the terms set out in the notice of Annual General Meeting.

An explanatory statement as required under the Share Repurchase Rules to provide the requisite information of the Repurchase Mandate is set out in Appendix I hereto.

3. AMENDMENT OF THE BYE-LAWS

To ensure compliance with the Listing Rules and to align the Bye-Laws with the new Code on Corporate Governance Practices (the "CG Code") as set out in Appendix 14 to the Listing Rules which came into effect on 1st January 2005, the Directors propose to amend the relevant Bye-Laws at the Annual General Meeting. The proposed amendments to the Bye-Laws are summarised as follows:

(a)	New Bye-Law 182(vi)	To provide that every Director shall be subject to retirement by rotation at least once every three years in accordance with the CG Code.
(b)	New Bye-Law 104	To provide that the Company be allowed to remove directors by ordinary resolution.
(c)	New Bye-Law 87	The Hong Kong Securities Clearing Company Limited ("HKSCC") has requested the Company to amend its Bye-Laws so as the Company allow a corporation to appoint multiple corporate representatives.

4. REFRESHMENT OF THE SHARE OPTION SCHEME MANDATE LIMIT

Pursuant to the resolution passed by the shareholders at the annual general meeting of the Company held on 31st December 2002, the new Share Option Scheme was adopted. The purpose of the Share Option Scheme is to enable the Company to attract, retain and motivate Eligible Participants to strive for future developments and expansion of the Group. It is important that the Group should continue to provide such Eligible Participants under the Share Option Scheme with an additional incentive and encouragements by offering them an opportunity to obtain an ownership interest in the Company and to enjoy the results of the Company attained through their efforts and contribution.

Since the adoption of the Scheme Option Scheme, the Company has granted options carry rights to subscribe for 82,828,000 Shares, in which 80,920,000 Shares has been exercised and the remaining option of 1,908,000 Shares has been cancelled and expired. As such, there were no outstanding options in issue at the Latest Practicable Date.

Under the Share Option Scheme, the Directors were authorised to grant options to subscribe for Shares thereunder and to allot, issue and deal with Shares pursuant to the exercise of the options granted. The Company may grant options up to the limit imposed under the Share Option Scheme, i.e. 10% (equivalent to 336,335,582 Shares) of the issued share capital (3,363,355,826 shares) of the Company as at the date of adoption of the Share Option Scheme.

Apart from the Share Option Scheme, the Company has no other share option scheme currently in force. The Directors consider that the Company should refresh the limit under the Share Option Scheme so that the Company could have more flexibility to provide incentives to those Eligible Participants of the Share Option Scheme by way of granting share options to them.

In accordance to Listing Rules 17.03(3) note 1 and 2, the Group may seek approval by its shareholders in general meeting for "refreshing" the 10% limit under the scheme. However, the total number of securities which may be issued upon exercise of all options to be granted under all of the schemes of the Group (or the subsidiary) under the limit as "refreshed" must not exceed 10% of the relevant class of securities in issue as at the date of approval of the limit. Options previously granted under the schemes (including those outstanding, cancelled, lapsed in accordance with the scheme or exercised options) will not be counted for the purpose of calculating the limit as "refreshed". However, the limit on the number of securities which may be issued upon exercise of all outstanding options granted and yet to be exercised under the scheme and any other schemes must not exceed 30% of the relevant class of securities of the Group (or the subsidiary) in issue from time to time. No options may be granted under any schemes of the Group (or the subsidiary) if this will result in the limit being exceeded.

If the refreshment of the Share Option Scheme mandate limit is approved at the Annual General Meeting, based on the 3,363,355,826 Shares in issue as at the Latest Practicable Date and assume no further Shares are issued or repurchased after the Latest Practicable Date and up to the date of the Annual General Meeting, the Company will be allowed to grant further options under the Share Option Scheme for subscription of up to a total of 336,335,582 Shares, representing 10% of the issued share capital (3,363,355,826 shares) of the Company as at the date of the Annual General Meeting.

The Directors consider that the refreshment of the limit under the Share Option Scheme is in the interests of the Group and the shareholders as a whole because it enables the Company to reward and motivate its Employees and other Eligible Participants under the Share Option Scheme.

The refreshment of the limit under the Share Option Scheme is conditional upon:

- (i) the passing of the ordinary resolution at the Annual General Meeting; and
- (ii) the Listing Committee of the Stock Exchange granting the listing of, and permission to deal in any new Shares which may fall to be allotted and issued upon the exercise of the subscription rights attaching to the options that may be granted under the refreshed limit of the Share Option Scheme up to 10% of the issued share capital of the Company as at the date of passing of the relevant ordinary resolution at the Annual General Meeting.

5. ANNUAL GENERAL MEETING

Notice of the Annual General Meeting is contained in this circular. A form of proxy for use at the Annual General Meeting is also enclosed therewith.

The following Ordinary Resolutions, will be respectively proposed at such meeting:

- to grant to the Directors a general mandate to exercise all powers of the Company to repurchase on the Stock Exchange Shares representing up to 10% of the issued share capital of the Company as at the date of passing Ordinary Resolution No. 6;
- to grant to the Directors a general mandate to authorise the Directors to issue, allot and deal with Shares with an aggregate nominal value not exceeding 20% of the aggregate nominal amount of the issued share capital of the Company as at the date of passing Ordinary Resolution No. 7;
- to extend the general mandate which will be granted to the Directors to issue, allot and deal
 with additional Shares by adding to it the number of Shares repurchased under the Repurchase
 Mandate after the granting of the Share Issue Mandate; and
- to approve refreshment of the Share Option Scheme mandate limit with effect from the conclusion of the Annual General Meeting.

The following special resolution, will be proposed as such meeting:

 to approve amendment of Company's Bye-Laws with effect from the conclusion of the Annual General Meeting.

6. RE-ELECTION OF DIRECTORS

Pursuant to clause 102(B) of the Company's Bye-Laws, Mr. Leung Chi Hong, Jerry shall retire and being eligible, will offer himself for re-election in the Annual General Meeting.

Pursuant to clause 99(A) as amended by clause 182(vi) of the Company's Bye-Laws, Miss Leung Chi Yin, Gillian will retire and, being eligible, offer herself for re-election in the Annual General Meeting.

Brief biographical and other details of the above Directors are set out in Appendix II to this circular.

7. PROCEDURE TO DEMANDING A POLL

Pursuant to clause 70 of the Company's Bye-Laws, at any general meeting a resolution put to the vote of the meeting shall be decided on a show of hands unless a poll is (before or on the declaration of the result of the show of hands or on the withdrawal of any other demand for a poll) demanded:—

- (i) by the Chairman of the Meeting; or
- (ii) by at least three members present in person (or, in the case of a member being a corporation, by its duly authorised representative) or by proxy for the time being entitled to vote at the meeting; or
- (iii) by any member or members present in person (or, in the case of a member being a corporation, by its duly authorised representative) or by proxy and representing not less than one-tenth of the total voting rights of all the members having the right to vote at the meeting; or
- (iv) by any member or members present in person (or, in the case of a member being a corporation, by its duly authorised representative) or by proxy and holding shares in the Company conferring a right to vote at the meeting being shares on which an aggregate sum has been paid up equal to not less than one-tenth of the total sum paid up on all the shares conferring that right.

In accordance with the requirements of the Listing Rules, the results of the poll will be published by way of an announcement in the local newspapers on the business day following the meeting.

8. ACTION TO BE TAKEN

Whether or not you intend to attend the Annual General Meeting, you are requested to complete the accompanying proxy form and return it to the company registrar of the Company in Hong Kong, Tengis Limited, at 26th Floor, Tesbury Centre, 28 Queen's Road East, Wanchai, Hong Kong not later than 48 hours before the time appointed for holding the Annual General Meeting or any adjournment thereof. Completion and return of the proxy form will not preclude shareholders of the Company from attending and voting in person at the Annual General Meeting if they so wish.

9. RESPONSIBILITY STATEMENT

This circular includes particulars given in compliance with the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited for the purpose of giving information with regard to the Company. The directors of the Company collectively and individually accept full responsibility for the accuracy of the information contained in this document and confirm, having made all reasonable enquiries, that to the best of their knowledge and belief there are no other facts the omission of which would make any statement herein misleading.

10. RECOMMENDATION

The Directors believe that the granting of the Repurchase Mandate, Share Issue Mandate, the amendment of Company Bye-Laws, and the refreshment of Share Option Scheme mandate limit are all in the best interests of the Company and its shareholders and so recommend you to vote in favour of the related resolutions at the Annual General Meeting. The Directors will exercise their voting rights in respect of all of their shareholdings (if any) in favour of the resolutions.

This appendix serves as an explanatory statement, as required by the Share Repurchase Rules, to provide requisite information to you for your consideration of the proposal to permit the repurchase of Shares up to a maximum of 10 per cent of the issued share capital of the Company as at the date of approval for the Repurchase Mandate.

SHARE CAPITAL

As at the Latest Practicable Date, the number of Shares in issue was 3,363,355,826. On the basis of such figure, assuming that no Shares would be issued or repurchased thereafter and prior to the Annual General Meeting, the Directors would be authorized to repurchase Shares up to a limit of 336,335,582 Shares (representing 10% of 3,363,355,826 issued share capital).

REASON FOR REPURCHASES

The Directors have no present intention to make any repurchase of the Company's own Shares but consider that the mandate will provide the Company the flexibility to make such repurchases when appropriate and beneficial to the Company and its shareholders. Such repurchases may enhance the net asset value of the Company and/or earnings per Share. Based on the financial position of the Company as at 31st July 2006 (being the date of its latest published audited accounts), there could be a material adverse impact on the working capital and on the gearing position of the Company in the event that the proposed repurchases were to be carried out in full during the proposed repurchase period. However, the Directors do not propose to make any repurchases in the circumstances that would have a material adverse impact on the working capital or gearing ratio of the Company.

FUNDING FOR REPURCHASES

Repurchases must be funded out of funds legally available for the purpose in accordance with the laws of Bermuda, the Memorandum of Association and the Bye-Laws of the Company. It is envisaged that the Company will derive the funds for repurchase of its shares in accordance therewith.

The Company is empowered by its Memorandum of Association and Bye-Laws to repurchase its own Shares. Bermuda law provides that the amount of capital repaid in connection with a share repurchase may only be paid out of either the capital paid up on the relevant shares, or out of the funds of the company that would otherwise available for distribution by way of dividend or the proceeds of a new issue of shares made for such purpose. The amount of premium payable on the repurchases, if any, may only be paid out of either the funds of the Company that would otherwise be available for distribution by way of dividend or out of the share premium of the Company. Further, the Company may not purchase its own Shares if, on the date on which the purchase is to be effected, there are reasonable grounds for believing that the Company is or, after the purchase would be, unable to pay its liabilities as they become due.

DIRECTORS, THEIR ASSOCIATES AND CONNECTED PERSONS

None of the Directors, to the best of the knowledge and belief of the Directors having made all reasonable enquiries, nor any of their Associates has any present intention, in the event that the proposed general mandate is approved by shareholders, to sell Shares to the Company.

No connected person (as defined in the Listing Rules) of the Company has notified the Company that he/she has any present intention to sell Shares to the Company nor has he/she undertaken not to sell any of the Shares held by him/her to the Company in the event that the Company is authorized to make repurchases of its own Shares.

UNDERTAKING OF THE DIRECTORS

The Directors have undertaken to the Stock Exchange to exercise the power of the Company to make repurchases pursuant to the proposed Repurchase Mandate in accordance with the Listing Rules, all applicable laws of Bermuda and the regulations, and the Memorandum of Association and Bye-Laws of the Company.

EFFECT OF TAKEOVER CODE

If, on the exercise of the power to repurchase Shares pursuant to the Repurchase Mandate, a shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition for the purpose of the Takeovers Code. Accordingly, a shareholder, or group of shareholders acting in concert, could obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rule 26 of the Takeovers Code.

As at the Latest Practicable Date, to the best of the knowledge and belief of Directors, Mrs. Leung Yu Oi Ling, Irene ("Mrs. Leung"), the Chairman of the Company and her children and Associates together hold approximately 75% of the issued share capital of the Company, while Mr. Yeo Boon Ann, the administrator of the UDL Scheme holds approximately 7.5% of the issued share capital of the Company on trust for the creditors under the UDL Scheme pending distribution pursuant to the terms of the UDL Scheme. In the event that the Directors should exercise the power in full to repurchase Shares which is proposed to be granted pursuant to the relevant Ordinary Resolution and if there is no other change in issued share capital of the Company, total interests of Mrs. Leung and Mr. Yeo Boon Ann in the issued shares would be increased to approximately 83% and 8% respectively of the total issued share capital of the Company. The Directors will not exercise the Repurchase Mandate that will result in the number of Shares held by the public being reduced to less than 25%. The Directors do not have any present intention to exercise the proposed Repurchase Mandate to such an extent as would give rise to such an obligation. Save as disclosed above, the Directors, to the best of their knowledge and belief, are not aware of any other substantial shareholders holding 5% or more of the issued share capital of the Company as at the Latest Practicable Date.

REPURCHASES AND SHARE PRICES

During each of the six months preceding the date of this circular, the Company has not repurchased any of its Shares. During each of the previous twelve months from 1st November 2005 to the Latest Practicable Date, the highest and lowest traded prices for Shares on the Stock Exchange were as follows:

The biographical and other details of the Directors standing for re-election at the Annual General Meeting are set out below:

Miss Leung Chi Yin, Gillian, aged 26, daughter of Mrs. Leung Yu Oi Ling, Irene, was redesignated in September 2002 as an Executive Director. Miss Leung graduated in Commerce from Queen's University, Canada and also completed MSc Law and Accounting from the London School of Economic and Political Science, London. Miss Leung is responsible for financial management and administration of the Group.

She is related to two executive directors of the Company being the daughter of Mrs. Leung Yu Oi Ling, Irene and the sister of Mr. Leung Chi Hong, Jerry. Miss Leung has personal interest in 2,378,800,675 (representing 70.7% of the issued share capital of the Company as at the Latest Practicable Date) shares of the Company within the meaning of Part XV of the Securities and Futures Ordinance. Save as the above, Miss Leung did not hold any directorship in other listed public companies in the last three years. Miss Leung is and was not connected with any director, senior management of the Company. She is connected to the substantial or controlling shareholders of the Company.

Miss Leung will receive salary of HK\$35,000 and S\$2,550 per month with Mandatory Provident Fund, which was determined by the Board based on authorisation to be granted by the shareholders at the Annual General Meeting and with reference to her duties and responsibility with the Company, the Company's performance and current market situation.

There is no information relating to Miss Leung that is required to be disclosed pursuant to rule 13.51(2)(h) to (v) of the Listing Rules, and there are no other matters that need to be brought to the attention of the shareholders of the Company.


Mr. Leung Chi Hong, Jerry, aged 24, appointed as the executive Director on 1st October 2006. Mr. Leung posses BSc in Physics and Computer from McGill University, Canada. He has over three years of experience in ship management in mainland China and South East Asia. He is currently working as the general manager of the Group's marine division.

He is related to two executive directors of the Company being the son of Mrs. Leung Yu Oi Ling, Irene and the brother of Miss Leung Chi Yin, Gillian. Mr. Leung has personal interest in 2,332,108,249 (representing 69.3% of the issued share capital of the Company as at the Latest Practicable Date) shares of the Company within the meaning of Part XV of the Securities and Futures Ordinance. Save as the above, Mr. Leung did not hold any directorship in other listed public companies in the last three years. (c) Bye-Law 87

By the addition after Bye-Law 87 of the following as Bye-Law 87(A) and 87(B):

87(A) Any corporation which is a shareholder of the Company may, by resolution of its directors or other governing body or by power of attorney, authorise such person or persons as it thinks fit to act as its corporate representative or corporate representatives, to the extent permitted by the Companies Act, at any meeting of the Company or of any class of shareholders of the Company provided that, if more than one person is so authorised, the authority shall specify the number and class of shares held by the relevant shareholder in respect of which each such person is authorised to act as such corporate representative. A person so authorised shall be entitled to exercise the same powers on behalf of the corporation which he represents as that corporation could exercise if it were an individual shareholder of the Company, save and except at any meeting on a show of hands the corporate representative or corporate representatives shall not have the right to vote individually but only one corporate representative may vote on a show of hands. References in these Bye-Laws to a shareholder present in person at a meeting shall, unless the context otherwise requires, include a corporation which is a shareholder represented at the meeting by such duly authorised corporate representative or by one or more proxies. Nothing contained in this Bye-Law 87(A) shall prevent a corporation which is a shareholder of the Company from appointing one or more proxies to represent it pursuant to Bye-Law 81.

(B) If a Clearing House (or its nominee(s)) is a shareholder of the Company, it may authorise such person or persons as it thinks fit to act as its proxy or proxies or as its corporate representative or representatives at any meeting of the Company or at any meeting of any class of shareholders of the Company provided that if more than one proxy or corporate representative is so authorised, the proxy form or authorisation shall specify the number and class of shares in respect of which each such proxy or corporate representative is so appointed. A person so authorised under the provisions of this Bye-Law 87(B) shall be entitled to exercise the same rights and powers on behalf of the Clearing House (or its nominee(s)) which be represents as that Clearing House (or its nominee(s)) could exercise as if it were an individual shareholder including the right to vote individually on a show of hands notwithstanding any contrary provisions contained in these Bye-Laws. The number of persons a Clearing House (or its nominee(s)) may appoint to act as its corporate representative or representatives shall not exceed the number of shares held by that Clearing House (or its nominee(s)), being shares in respect of which there is an entitlement to attend and vote at the relevant meeting."
