NOTICE IS HEREBY GIVEN that the Annual General Meeting of the Company will be held at Room 706, 7th Floor, Hong Kong International Trade & Exhibition Centre, No. 1 Trademart Drive, Kowloon, Hong Kong on 29th December 2008 at 10:00 a.m. for the following purposes:

- 1. To receive and consider the audited consolidated financial statements and reports of the Directors and the auditors of the Company for the year ended 31st July 2008.
- 2. To re-elect Mr. Leung Yat Tung, a retiring director, as an executive director.
- 3. To re-elect Miss Leung Chi Yin, Gillian, a retiring director as an executive director.
- 4. To re-elect Mr. Pao Ping Wing, JP, a retiring director, as an independent nonexecutive director.
- 5. To authorise the board of directors of the Company to fix the remuneration of the directors.
- 6. To re-appoint CCIF CPA Limited as the Company's auditors and to authorise the Directors to fix their remuneration.
- 7. To grant a general mandate to the board of directors to repurchase shares in the Company, not exceeding 10% of the issued share capital of the Company as at the date of passing this resolution.
- 8. To grant a general mandate to the board of directors to allot, issue and deal with additional shares in the Company, not exceeding 20% of the issued share capital of the Company as at the date of passing this resolution.
- 9. Conditional on the passing of resolution 7 and 8, to extend the general mandate granted by resolution 8 by adding thereto the shares repurchased pursuant to the general mandate granted by resolution 7.

10. To refresh the Company's Share Option Scheme mandate limit up to 10% of the issued share capital of the Company as at the date of passing this resolution.
