1. 收集 閣下個人資料的原因

如 閣下就本身之股份接納要約, 閣下須提供所需之個人資料。倘 閣下未能提供所需資料,則可能導致 閣下之接納申請被拒或受到延誤。如所提供的資料不準確, 閣下須即時知會要約人、聯合證券有限公司及/或過戶登記處。

2. 用途

閣下於本接納表格提供之個人資料可能會用作、持有及/或保存(以任何方式)作下列用徐:

- 處理 閣下之接納申請及核實 閣下是否已遵循本接納表格及要約文件載列的條款及申請手續;
- 登記以 閣下名義作出之股份轉讓;
- 保存或更新有關股東名冊;
- 核實或協助核實簽名,以及進行任何其他資料核實或交換;
- 由要約人及/或其代理(如聯合證券有限公司及過戶登記處)發佈通訊;
- 編製統計資料及股東概況;
- 按法例、規則或規例(無論法定或其他規定)作出披露;
- 確立 閣下於要約項下之權益;
- 有關要約人、本公司或過戶登記處業務之任何其他用途;及
- 有關上文所述任何其他附帶或關聯用途及股東可能不時同意或知悉的其他用途。

3. 轉交個人資料

於本接納表格所提供之個人資料將作為機密資料保存,惟要約人、聯合證券有限公司及/ 或過戶登記處為達致上述或有關任何上述之用途,可能作出彼等認為必須之查詢,以確認 個人資料之準確性,尤其可向或自下列任何及所有個人及實體披露、獲取、轉交(無論在香 港或香港境外的地區)該等個人資料:

- 要約人及/或其代理,如聯合證券有限公司及過戶登記處;
- 為要約人、聯合證券有限公司及/或過戶登記處之業務經營提供行政、通訊、電腦、付款或其他服務之任何代理、承包商或第三方服務供應商;
- 任何監管或政府機構;
