Pursuant to the Share Reorganisation of Kiu Hung International Holdings Limited ("the Company") which was effective on 17 September 2020, (i) the share consolidation of every twenty issued and unissued Shares of HK\$0.1 each in the capital of the Company into one Consolidated Share of HK\$2.00 each; and (ii) the issued share capital of the Company was reduced through a cancellation of the paid-up capital of the Company to the Extent of HK\$1.99 on each of the issued Consolidated Shares such that the nominal value of each issued Consolidated Share was reduced from HK\$2.00 to HK\$0.01; (iii) Each of the authorised but unissued Consolidated Share of HK\$2.00 each was sub-divided into 200 New Shares of HK\$0.01 each.
